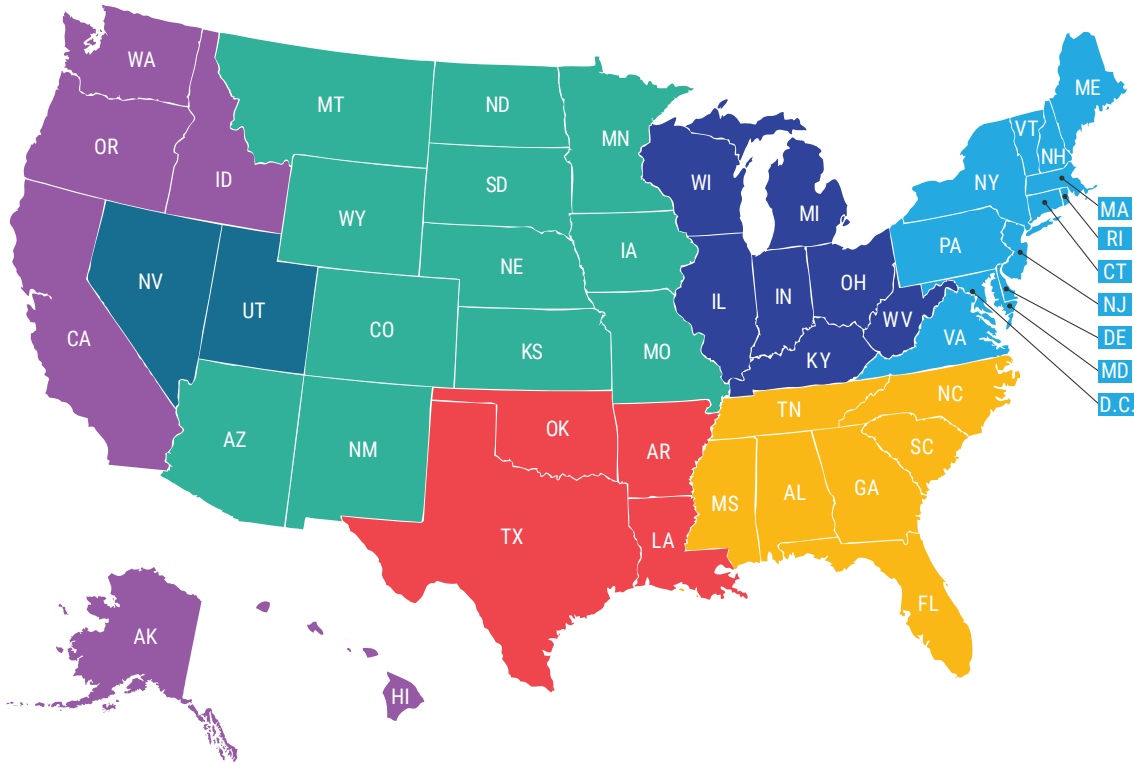


THE SALES TEAM TERRITORY MAP
