



To assist shareholders with year-end planning, ICON Funds has released estimated 2017 dividends and capital gain distributions. These estimates are per share and based on income and capital gain information through December 14, 2017 and consider shares outstanding as of December 14, 2017.

We anticipate that the ICON Funds will pay actual dividends and capital gain distributions on or before December 21, 2017 to shareholders of record on December 19, 2017. Please note that this is an anticipated schedule, and we cannot assure that distributions will be paid on the expected date.

Net investment income, or ordinary income, will include estimated activity through December 31, 2017 and will be based on shares outstanding as of the record date. Actual dividends and capital gain distributions paid to shareholders may change significantly from the estimates shown below due to portfl-management, market and shareholder activity, and tax adjustments.
